Partner Spiff Program Terms and Conditions:

Under this program, existing channel partners who are directly contracted in good standing with Fusion Connect are eligible to participate. Excludes Referral Partners. Partner spiff payout is capped at \$100K per customer account. POTS spiff payout is \$50/line if no end user promotion is applied with a three (3) year contract term, and \$10/line if 2-months-free end user promotion is applied with a three (3) year term. Voice and Unified Communications spiffs are valid with a minimum 5x for 3 years and 3x for 2 years contract term. For SD-WAN, Security and Managed WiFi, services must be ordered with a minimum three (3) year contract term. Spiffs are calculated monthly, based on total installations, and will be distributed via the standard commission payout process. If customer cancels at any time before installation, spiff will be voided. Or, if spiff has already been paid and customer terminates or has been terminated due to non-payment within twelve (12) months after installation for Voice and UCaaS spiffs, or six (6) months after installation for all other spiffs, Fusion Connect reserves the right to deduct the amount of the spiff from future commission payments. Only sales of new services/seats qualify for the spiff. Circuits SPIFF must be bundled with Hosted Voice to Qualify for 1X Spiff on data circuits. Bundle sales must be completed within 90 days of initial hosted voice or data circuit order to qualify. Renewals, upgrades, downgrades, or moves of existing services/seats do not qualify. Service selling price must be at or above the list/publicly advertised price to be eligible for the spiff unless otherwise noted. The person or company that receives the spiff is responsible for all the taxes and liability associated with the Fusion Connect Spiff Program.
